**A RESOLUTION OF THE CITY OF BURIEN, WASHINGTON
AUTHORIZING EXECUTION OF AN INTERLOCAL AGREEMENT
WITH KING COUNTY AND MEMBER JURISDICTIONS FOR
CLIMATE COLLABORATION**

WHEREAS, the King County-Cities Climate Collaboration (K4C) is an entity comprised of the King County and participating King County cities working together to respond to climate change and to reduce global and local sources of climate pollution; and

WHEREAS, toward this goal, K4C would focus efforts on sharing information and educating the public and government agencies on the issue of climate change, collaborating on adopting consistent planning standards and strategies related to climate change, and securing funding and resource opportunities to support climate change related projects and programs; and

WHEREAS, partnering with King County and other jurisdictions that are members of K4C on sustainable solutions will advance progress towards environmental, climate change, and energy goals such as those adopted by the nearly half of King County Cities that have signed on to the U.S. Conference of Mayors Climate Protection Agreement; and

WHEREAS, participation as a member jurisdiction of K4C would require execution of the Interlocal Agreement, attached hereto as Exhibit “A”, and an initial financial contribution to support the activities of K4C; and

WHEREAS, the Interlocal Agreement provides that future increases in member jurisdiction funding obligations would be binding only upon a member jurisdiction voting in support of such a funding obligation; and

WHEREAS, the City Council finds that it is in the best interest of the public that the City become a member jurisdiction of K4C;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BURIEN, WASHINGTON, DOES RESOLVE AS FOLLOWS:

Section 1. Authorize Execution of Interlocal Agreement. Based upon the foregoing, the City Manager is hereby authorized on behalf of the City to execute an Interlocal Agreement with King County in substantially the form of the Interlocal Climate Collaboration Agreement attached hereto as Exhibit “A”.

Section 2. Effective Date. This resolution shall take effect immediately upon passage.
