2014 NEC Changes as adopted and amended in BMC 15.10.140

- NEC 210.8 – GFCI Protection required on All 120-volt, single phase, 15- and 20-ampere receptacles installed within 6 ft of any dwelling unit sink (Refrigerator), bathtub or shower stall, in addition to Disposer, Dishwasher and Laundry Areas.
- NEC 210.12 - AFCI Protection required on All 120-volt, single phase, 15- and 20-ampere branch circuits supplying outlets installed in dwelling unit, except Bathrooms and Garage.
- All GFCIs and AFCI devices to be installed in readily accessible locations. (Capable of being reached quickly for operation without requiring tools, ladders and so forth)
- NEC 210.17 – Branch circuit required for electric vehicle (EV) charging.
- NEC 210.52(E)(3) Balconies, Decks, and Porches that are attached to the dwelling unit and /or with a usable area of more than 20 square feet shall have at least one receptacle outlet installed.
- NEC 314.27(A)(2) – Ceiling boxes shall be listed and marked on the interior of the box for maximum weight the box shall be permitted to support.
- NEC 404.2(C) – Grounded (neutral) conductor required at all switch locations.
